**Agenda Item No. 2**

**Total workshop on Homoeopathic Medical Education Technology Modules I & II conducted by Central Council of Homoeopathy so far.**

The Committee on Excellence in Education discussed the matter and it recommended to conduct the workshops in respect of Module I & Module II in a combined manner for three days in the following Colleges -

1. In Homoeopathic University, Jaipur or in its constituent college during August, 2014 for which the liaisoning work may be done by Dr. Amiya Goswami, Member and in this

workshop all the colleges in Himachal Pradesh, UT Chandigarh, Haryana, Punjab and Rajasthan will participate.

2. In Govt. Homoeopathic Medical College, Bhopal during October, 2014 (preferably in the first week) for which the liaisoning work may be done by Dr. Ayesha Ali, Member, CCH and in this workshop all the colleges of the States of Madhya Pradesh and Chhatisgarh will participate.
3. In Ahmedabad Homoeopathic Medical College, Ahmedabad during December, 2014 for which the liaisoning work may be done by Dr. Parul J. Patel, Member and in this workshop all the colleges of the State of Gujarat will participate.

The Committee also recommended for conduct of one workshop on Module II only at NIH, Kolkata during January, 2015 wherein liaisoning will be done Dr. S.K. Nanda, Member and in this workshop all the colleges of West Bengal, Bihar, U.P. and Orissa can participate.

The Central Council will pay the TA/DA restricted to 2<sup>nd</sup> A.C. Train only and not in higher class or by air, to participants. The Council will bear the expenditure of TA/DA and honorarium in respect of resource persons preferably by 2<sup>nd</sup> A.C. train but in case of non-availability of 2<sup>nd</sup> A.C. train the higher classes of journey including air journey can be considered. Besides the Chairman and members of the Committee on Excellence in Education, the Chairman of Education and P.G. Education Committees will also be invited to attend the said workshops. The President and Vice-President of the Council will be requested to be the Chief Guest and Presiding Officer respectively for the inauguration of such workshops. The concerned officer(s) and the staff of the Council may be deputed as decided by the President. Assessment forms for evaluation of the participants will be made for these workshops. Feedback forms about the utility of these workshops to be filled by participants may also be provided. 


